Sir/ Madam,

Sub: Termination Letter for non-submission of 50% Annual Sand Premium as H1 Bidder Ref: Memo No.: (i) MDTC / SAND / 003 / Part - 3 / 65 (10 of 20) dated 09.01.2023 (ii) MDTCL / SAND / 003 / Part - 3 / 231 (9 of 9) dated 31.01.2023

Whereas based on the decision taken by the Tender Evaluation Committee and as per Clause No. 8.4.1 in the respective RFP and notice under reference was issued to the H1 Bidders in respect to each RFP for 20 sand blocks for which e-auction was held on 02.01.2023.

Whereas as per notice under reference (i) you were requested to submit 50% Annual Sand Premium amount within 30.01.2023. which you have failed to comply with.

Whereas, as per Notice under reference (ii) you were given an additional time till 15.02.2023 for submission of the said amount as a second and final opportunity.

Whereas, you have again failed to make the payment within the stipulated time and you were also informed the following that in case you fail to pay 50% of the Advance Sand Premium amount appropriate action will be initiated against you as per the respective Clauses of RFP as below:

Hence, considering the above, the following action has been initiated against you,

- i. The Earnest Money Deposit (EMD) amount of Rs. 2,48,000/- submitted by you vide Demand Draft No.: 988668 dated 21.12.2022 drawn on Punjab National Bank Ltd. has been forfeited;
- ii. Your empanelment vide this Office Memo No.: MDTC/ SAND/ 002/ 1027 dated 30.12.2021 as Contractors for excavation, dredging/desiltation, transportation of sand mines to stock-yards / depots, setting up and maintenance of stock-yards/ depots, loading sand on the vehicle and sale of sand to end-consumer in the State of West Bengal has been terminated and cancelled with immediate effect.
- iii. You have been Blacklisted with immediate effect as the bidder from the list of empanelled operators for excavation and transportation of sand mines to stock-yards / depots, setting up and maintenance of stock-yards/depot, loading sand on the vehicle and sale of sand to end-consumer in the State of West Bengal.

Please note, no further communication in this regard will be entertained.
