
Sub: Modification of the Provisional Grant Order dated 04.09.2019 for Long term Mining Lease for Coal in favour of West Bengal Power Development Corporation Ltd. over an area of about 138.77 Ha in respect of Gangaramchak & Gangaramchak Bhadulia Coal Mine located in six mouzas under P.S. Khoirasol, Dist. Birbhum.

Sir,

I am directed to refer to your letter No. WBPDC/Director (Mining)/ 822 dated 02.01.2020 & No. WBPDC/Director (Mining)/ 824 dated 06.01.2020 and Provisional Grant Order No.490-CI/O/MIN/GEN-COL/07/2015 (Pt.) dated 04.09.2019 issued from this Department on the subject mentioned above and to state that in exercise of the powers conferred by sub-section (3) of section 10 of the Mines and Minerals (Development and Regulation) Act, 1957, the Governor has been pleased to consider and modify the provisional grant order dated 04.09.2019 of mining lease for Coal excluding the area of 37 Ha from the original grant area of 138.77 Ha on account of non-obtainment of necessary clearances including certificate for non-coal bearing.

Presently, the total area of grant for coal mining is 101.77 Ha for a period of **26(twenty six) year** in favour of West Bengal Power Development Corporation Ltd. in terms of Allotment Order No. **103/8/2015/NA dated 31.03.2015** of the Ministry of Coal, Government of India subject to fulfillment of and compliance with all other conditions specified in the said Provisional Grant Order.


