1. Scope of Services:

- a) Preparation of Digital database of Potential Sand Mining Ghats of 1000 hectares for auction by WBMDTCL as per the approved District Survey Reports across the state of West Bengal after taking into consideration the running mines, already auctioned mines at various stages of obtaining clearances.
- b) Preparation of GIS based maps of all the Mining Leases as listed above.
- c) Preparation of GIS based maps for all the newly identified Potential Sand Ghats/Clusters.
- d) Site visit for observing the accessibility, approaches, other site problems if any, probable transportation routes, social issues if any etc
- e) Assisting WBMDTCL in Obtaining NOC from district level committee for sand mining auctions for the 1000 hectares including district visit if required

2. Time Period

The consulting agency shall within 3 weeks from the date of issuance of work order, the 1000 hectares is to be identified with geo-coordinates across the state and shared with WBMDTCL for sharing to the districts from the potential sand mining zones as per the approved District Survey Reports .

Final NOC to be obtained from respective districts within 2 weeks from sharing of the data. Time extension if any may be granted as per sole discretion of WBMDTCL.

Only database for running mines and already auctioned mines shall be provided by WBMDTCL along with the work order . No other data shall be provided by WBMDTCL to the selected agency .

3. Eligibility Criteria :

Note:

i. The Bidder must depute the required Manpower for satisfactory execution of work as per the decision of WBMDTCL. The Bidder with prior written approval of WBMDTCL may engage sufficient number of support persons as necessary over and above the specialists as stated in the table above, who will assist the team member for on time submission and approval of the Authority.

ii. Any additional activity (including visit of Experts), beyond the above activities, which WBMDTCL will intend to execute through the Bidder, will be executed by the Bidder at an additional price and any other terms & conditions, which will be mutually agreed upon by both WBMDTCL and the selected bidder. However, the value of the additional work shall be limited to maximum 20% of the awarded work value.

iii. All bidders will be required to make a presentation in presence of their proposed experts on their Technical Bid to facilitate the understanding and evaluation of its Technical Bid. The scope of such presentation shall be limited to information already provided in the Technical Bid.

v. All Key Experts will be associated till end of the. Replacement of personnel is strictly not allowed in the entire duration of the contract without prior permission and formal approval of WBMDTCL.

The Bidders who have successfully submitted documents marked under "Eligibility criteria For Technical Bid"

of Clause 6 above, will be invited to make a presentation before the Bid Evaluation Committee of WBMDTCL on the date, time and venue to be intimated in due course. The purpose of the presentation will be to allow the bidders to present their experience in preparation of such type of Centralised Database for Sand Mining.

The Bid Evaluation Committee of WBMDTCL will examine each proposal on the basis of the documents submitted and the presentation made by the bidders and assign scores against each of the Technical Bid Scoring Parameters. The Committee may seek oral clarifications from the bidders during presentation. The purpose of such oral clarification in the evaluation process is to clarify ambiguities and uncertainties in the proposed solution of the bidder. The clarifications are intended to provide opportunities to the Committee to state its expectations from the proposed solutions with more clarity and for the bidders to explain their proposals with more clarity. The Committee may, at its discretion, seek inputs from external professionals/technical experts in the process.

Only the Bidders with Technical Bid Score of 45 and above will be eligible for Financial Bid evaluation. Financial Bids of the unsuccessful bidders who will score less than 45 shall not be opened.

b) Financial Bid Opening:

The Financial Bids of only those bidders who satisfy **ALL of the Pre-Qualification Criteria AND obtain Technical Bid Score of 45 and above** shall be opened online in the e-Procurement Portal of the Government of West Bengal as per the Bid Schedule. Financial Bids not conforming to the format prescribed in this RFP would be rejected.

c) Total Bid Evaluation:

Bids will be finally evaluated on the basis of "**Quality and Cost Based Selection (QCBS)**" method. A ratio of 70:30 (i.e.; 70% weightage for Technical Score and 30% weightage for Financial Score) will be followed for the QCBS. Following steps will be followed for ranking the bidders.

i. Normalisation of Financial Score

Financial Bids of the Technically Qualified Bidders will be assigned a Normalised Financial Score (F_n) on a scale of 30 points as follows;

$F_n = (F_{min} / F_b) * 30$

Where

F_n = Normalised Financial Score of the Bidder under consideration

F_{min} = The Lowest Financial Bid received from a Technically Qualified Bidder, and

 F_b = The Financial Bid quoted by the bidder under consideration

ii. Final Evaluation and Declaration of Preferred Bidder

The Combined Score (S_c) of a bidder will be calculated by giving 70% weightage to his Technical Score (T_n) and 30% weightage to his Normalised Financial Score (F_n) as follows;

$S_c = T_n + F_n$

Where

- S_c = The Combined Score of the bidder under consideration
- T_n = Normalised Technical Score of the bidder under consideration
- F_n = Normalised Financial Score of the bidder under consideration
 - iii. The bidder with Highest Combined Score (S_c) will be declared as the Preferred Bidder. The Preferred Bidder shall submit the original copy of the documents scanned and uploaded in the wbtenders portal for issuance of workorder within 3 working days from the date of declaration as preferred bidder. Incase of failure to do so WBMDTCL reserves the right to invoke the clauses 11 of Termination and Blacklisting

8. Payment Schedule :

25% after submission of the proposed 1000 hectares within 3 weeks from workorder date

50% after obtaining NOC for the 1000 hectares from the district authorities 25% after successful auction of the blocks

9. WBMDTCL reserves the right to change, modify, add or alter the document including cancellation of the tender at any time during the bidding process.

10. WBMDTCL reserves the sole right to accept or reject any or all bids without assigning any reason thereof.

11. Termination and Blacklisting

In the event the bidder

- 1. Is unable to finish the works in the timeline specified in Clause 2 : Time Period , the bidder is liable to
- If at any time such any declaration/document is found false, the bid will be rejected or if the contract work is already awarded, it will be terminated forthwith without payment of any compensation and the EMD/Performance Security/Additional Performance Security if applicable/ will be forfeited
- 3. Fails to abide by terms and conditions of this document
- 4. Fails to submit the original copy of the documents uploaded in the portal as per Clause 7c(iii)

In any of the aforestated circumstances WBMDTCL reserves the right to

- 1) terminate and blacklist the Bidder
- 2) Forfeit EMD/ Security Deposit of the Bidder

12. FORCE MAJEURE :

If, at any time, during the pendency of the contract, the performance in whole or in part, by either party is prevented or delayed by war, strike, riot, crime or due to any act of God such as hurricane, flooding, earthquake, volcanic eruption beyond the control of both the parties such as war, strike, insurrection, riot, earthquake, storm, flood, fire which are beyond the control of either party (hereinafter referred to as 'eventualities'), then provided notice of the happening of any such eventuality is given by either party to the other within 15 days from the date of occurrence thereof, neither party shall by reason of such eventuality be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such non-performance or delay in performance and work under this contract shall be resumed as soon as practicable after such eventuality has come to an end or ceased to exist and the decision of the WBMDTCL as to when the work has to be resumed shall be final and conclusive. The time of completion shall then be extended by a period equal to the period during which the eventuality was prevailing. In case of persisting delay of more than three months both the parties may consult each other and arrive at an appropriate decision regarding continuation or otherwise of the contract.

13. Limitation of Liabilities

Notwithstanding anything contained in the contract, WBMDTCL agrees that the Bidder shall not be liable to WBMDTCL, for any losses, claims, damages, liabilities, cost of expenses ("Losses") of any nature whatsoever, for an aggregate amount in excess of the fee paid under the contract for the services provided under the contract, except where such Losses are finally judicially determined to have arisen primarily from fraud or bad faith of the Bidder. In no event shall the bidder, be liable for any consequential (including loss of profit and loss of data), special, indirect, incidental, punitive or exemplary loss, damage or expense relating to the services provided pursuant to this contract.

14. Other Terms and Conditions

- a. The Bidder or its directors should not have been suspended/debarred/blacklisted/contract terminated by any Govt. authority/organization, nor there should be any order/declaration of insolvency, or judgement/order of punishment or sentence by any court of law or any judicial/quasi-judicial proceeding in force at the time of submission of bid. If at any time such declaration is found false, the bid will be rejected or if the contract work is already awarded, it will be terminated forthwith without payment of any compensation and the EMD/Performance Security/Additional Performance Security if applicable/ will be forfeited and the agency shall be blacklisted.
- b. To Avoid Fraud, Coercive and Undesirable practices Bidders and their respective officers, employees, agents and advisers shall observe the highest standard of ethics during the Bidding Process. Notwithstanding anything to the contrary contained herein, WBMDTCL may reject a Bid without being liable in any manner whatsoever to the bidder if it determines that the bidder has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice,

coercive practice, undesirable practice, restrictive practice, collusive bidding or bid rigging in the Bidding Process. Without prejudice to the rights of WBMDTCL under Clause hereinabove, if a bidder is found by WBMDTCL to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice, restrictive practice or collusive bidding or bid rigging during the Bidding Process, such a bidder shall not be eligible to participate in any tender or RFP issued by WBMDTCL during a period of 2 (two) years from the date. For the purposes of this Clause the following terms shall have the meaning hereinafter respectively assigned

(a) "corrupt practice" means

(i) the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence the actions of any person connected with the Bidding Process (for avoidance of doubt, offering of employment to, or employing, or engaging in any manner whatsoever, directly or indirectly, any official of WBMDTCL who is or has been associated in any manner, directly or indirectly, with the Bidding Process shall be deemed to constitute influencing the actions of a person connected with the Bidding Process);

(b) "fraudulent practice" means a misrepresentation or omission of facts or suppression of facts or disclosure of incomplete facts, in order to influence the Bidding Process;

(c) "coercive practice" means impairing or harming or threatening to impair or harm, directly or indirectly, any person or property to influence any person's participation or action in the Bidding Process;

(d) "undesirable practice" means

(i) establishing contact with any person connected with or employed or engaged by WBMDTCL with the objective of canvassing, lobbying or in any manner influencing or attempting to influence the Bidding Process; or

(ii) having a Conflict of Interest;

(e) "restrictive practice" means forming a cartel or arriving at any understanding or arrangement among bidders with the objective of restricting or manipulating a full and fair competition in the Bidding Process; and

(f) "collusive bidding" or "bid rigging" means any agreement, between enterprises or persons engaged in identical or similar production or trading of goods or provision of services, which has the effect of eliminating or reducing competition for bids or adversely affecting or manipulating the process for bidding
