Sub: Termination Letter for non-submission of 50% Annual Sand Premium as H1 Bidder
Ref: Memo No.: (i) MDTC/SAND/003/Part - 5/939 (8 of 32) dated 11.04.2023
(ii) MDTC/SAND/003/Part - 6/1223 (4 of 5) dated 15.05.2023

Whereas based on the decision taken by the Tender Evaluation Committee and as per Clause No. 8.4.1 in the respective RFP and notice under reference was issued to the H1 Bidders in respect to each RFP for 32 sand blocks for which e-auction was held on 10.04.2023.

Whereas as per notice under reference (i) you were requested to submit 50% Annual Sand Premium amount within 03.05.2023. You failed to make the payment within 03.05.2023. Hence, as per Notice under reference (ii) you were given an additional time till 31.05.2023 for submission of the said amount as a second and final opportunity. You were also informed the following that in case you fail to pay 50% of the Advance Sand Premium amount appropriate action will be initiated against you as per the respective Clauses of RFP No.: PSHMD_5_23032023_A03 dtd. 23.03.2023 as below:

- 1. Forfeiture of EMD as per Clause 8.2.2(d):**
- 2. Termination from empanelment list and blacklisting as per Clause 8.4 (5):** Non-compliance of submission of 1st Instalment under Clause 8.4.1 within the stipulated time line, WBMDTCL may terminate and Blacklist the bidder from the list of empaneled operators for excavation and transportation of sand mines to stock-yards / depots, setting up and maintenance of stock-yards / depot, setting up and maintenance of stock-yards / depot, loading sand on the vehicle and sale of sand to end-consumer in the State of West Bengal;
- 3. Acceptance of General Terms and Conditions as per Clause 10.1:** The bidder should unconditionally accept all the terms and conditions of the contract. Conditional Bids shall be rejected summarily

You have once again failed to pay the 50% Annual Sand Premium amount within the specified period as per our records. Thus, as per the clauses mentioned herein above,

- The Earnest Money Deposit (EMD) amount of Rs. 3,85,000/- submitted by you through online mode vide BRNIGAPJYCMH0 dtd. 05.04.2023 has been forfeited;
- Your empanelment vide this Office Memo No.: MDTC/ SAND/ 002/ 1027 dated 30.12.2021 as Contractors for excavation, dredging/de-siltation, transportation of sand mines to stock-yards / depots, setting up and maintenance of stock-yards/ depots, loading sand on the vehicle and sale of sand to end-consumer in the State of West Bengal has been terminated and cancelled with immediate effect.
- You have been Blacklisted with immediate effect as the bidder from the list of empanelled operators for excavation and transportation of sand mines to stock-yards / depots, setting up and maintenance of stock-yards/ depot, loading sand on the vehicle and sale of sand to end-consumer in the State of West Bengal.

Please note, no further communication in this regard will be entertained.
